counties. Most of the soybean, wheat and barley are grown under contract for Hundley Seed Company. Jay serves on the board of the Virginia Grain Producers Association. He has lived in Champlain, Virginia all of his life. His wife and two sons are active in the farming operation.

**David Mayonado** has served as a Technology Development Representative for Monsanto for the

past 25 years. David graduated from Bridgewater College in 1982. He has a strong background in chemistry, plant physiology and weed science. David is active in the Weed Science Society of America and the Northeastern Weed Science



Society. He is a native of Maryland and currently resides in Hebron, Maryland.

#### Dr. Sally Taylor is an entomologist with Vir-



ginia Tech. She is based out of the Tidewater Research and Extension Center in Suffolk. Dr. Taylor has received a grant to investigate an integrated pest management approach to mitigate crop damage from slugs.



**Kevin Matthews** and his wife own and operate Matthews Family Farms of North Carolina, Precision Nutrient Management, Inc. and Deep Creek Grain, Inc. in East Bend and Yadkinville, NC. Kevin investigates new technologies and utilizes test plots with a focus in no-till conservation and irrigation management. He has adopted subsurface drip irrigation on many acres.
